SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

DANGER. Extremely flammable. May be harmful if swallowed. Causes severe skin burns and eye damage.

EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing.

Immediately call a poison center or a physician.

SKIN: Take off immediately all contaminated clothing and wash it before reuse. Wash with plenty of soap and water/shower.

If skin irritation persists get medical attention.

INHALATION: Remove person to fresh air and keep comfortable for breathing. Immediately call a poison center or a doctor.

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:

Use water spray, fog or foam.

Specific hazards arising from the chemical:

Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed.

Hazardous thermal decomposition products:

Specific fire-fighting methods:

SECTION 6: Accidental Release Measures

Personal precautions:

Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.

SECTION 7: Handling and Storage
